#### General Terms of Use of Material

1. Throughout the following terms of use: “Bank” means the Bank of Greece (21 El. Venizelou, 10250 Athens, Greece); “User” means the natural or legal person requesting the Material for the agreed use; “Material” means the photograph, slide, digital image or file, as well as any multimedia storage device hereby provided; “reproduction” means any form of reproduction of the Material, including but not limited to by mechanical, photochemical, digital or electronic means (as in the context of electronic networks and the Internet). In case of reproduction for use in television, a non-exclusive authorisation of a single broadcasting is granted; in case of use in cinematography, a non-exclusive right of public projection is also granted.
2. The reproduction authorisation shall take effect upon signing of the present private agreement (“Authorisation of Use”) and any special terms accompanying it. The User shall have no right to transfer or consign the reproduction authorisation to third parties or to assign the rights acquired under the Authorisation of Use. In addition, the User may not provide or lease the Material to third parties. The User may not alter or modify the provided Material without the Bank’s prior written consent. Modification also means digital processing, which requires a specific authorisation.
3. The Bank is and shall remain the exclusive owner of the Material hereby provided, and the holder of all intellectual property rights associated with it.
4. The User shall have to label with the international mark of intellectual property registration (copyright) any use / reproduction of the copyrighted Material, accompanied by the year of first release as this shall be indicated by the Bank (e.g. © 2018 Bank of Greece, or © 2018 by Bank of Greece).
5. The Bank shall have the right to refuse the provision of the Material, at any time, free of any justification obligation.
6. The reproduction authorisation of the Material hereby granted is non-exclusive. Any and all special terms agreed between the User and the Bank shall always take precedence over the general terms.
7. A specific agreement is required for special reproduction cases (e.g. Internet, multimedia commercial operations, advertising leaflets, posters, etc.).
8. In case the Bank provides the User with any Material in printed form (slide, photograph, etc.), the User shall have to return it within a time period of three months from the date of its dispatch. The Material shall be considered to have been delivered to the User in good condition, unless the latter notifies the Bank within three days. In case of failure to return, or of loss, damage or destruction, the Bank shall be entitled to exercise all legal rights to remedy the damages incurred. The User is advised to insure the Material.
9. Any photographing of the Material shall be carried out by the Bank’s Photographic Documentation Laboratory; otherwise, by persons and photo labs selected exclusively by the Bank.
10. Upon release / publication of the product for which the reproduction authorisation of the Material is hereby granted, the User shall have to immediately submit to the Bank’s Centre for Culture, Research & Documentation the agreed number of copies (as stated in the Special Terms). Failure to comply with this obligation shall entail refusal to provide any new material in the future.
11. For uses of the Material in CD-ROM form, the resolution setting should not exceed 640x480 pixels and the printing scaling level should be less than 100 dpi. The User shall have to use special software that precludes digital copying of the Material.
12. The User, immediately after use of the Material in digital form, shall have to destroy the Material and inform the Bank in writing of such destruction.
13. These terms of use have been drafted and shall be interpreted according to the provisions of Greek law. Any dispute arising in relation to them shall be under the jurisdiction of the Courts of Athens.
